



Mexican Airspace and Over-time Fee Inquiry and Payment Request

Instructions

These forms are to be used for determining any amounts owed for Mexican airspace or overtime fees with the Mexican government as well as for paying Mexican airspace/overtime fees owed.

A. To make an inquiry to SENEAM for airspace or overtime fees owed for past flights:

1. Copy the text from page 2 of this document into a separate Word file
2. Insert your company letterhead where indicated
3. Fill out all the spaces marked in yellow with the required information
4. Sign where indicated
5. Save the document as: Carta-Solicitud.docx

From your personal email:

1. Copy the text from page 3 of this document into the content of your email, completing the fields marked in yellow with the required information
2. Write the subject line as indicated "Adeudos" and insert the aircraft's tail number
3. Attach the Word document created in step 5 above
4. Attach a scanned copy of the Registration Certificate for the aircraft
5. Send to the following email address: miguel.valles@sct.gob.mx with copies to: maria.leon@sct.gob.mx, d_operacion@sct.gob.mx and info@caribbeanskytours.com

When you receive a response from SENEAM:

1. Forward the information received to info@caribbeanskytours.com
2. We will calculate the amount owed in U.S. Dollars including any applicable back taxes and interest
3. We will email you the total amount owed including our payment processing fee
4. Once payment has been processed, a copy of the payment confirmation from the Mexican bank will be emailed to you.

B. To have CST make payment to SENEAM on your behalf for any specific flights made in the previous month:

1. Flight history must be emailed to info@caribbeanskytours.com within the first 5 days of the month after the flight took place. Flight history MUST include:
 - a. Tail number
 - b. Aircraft Type
 - c. Date of each flight
 - d. Departure and Arrival airport of each flight
2. We will email you the total amount owed including our payment processing fee
3. Once payment has been processed, a copy of the payment confirmation from the Mexican bank will be emailed to you.
